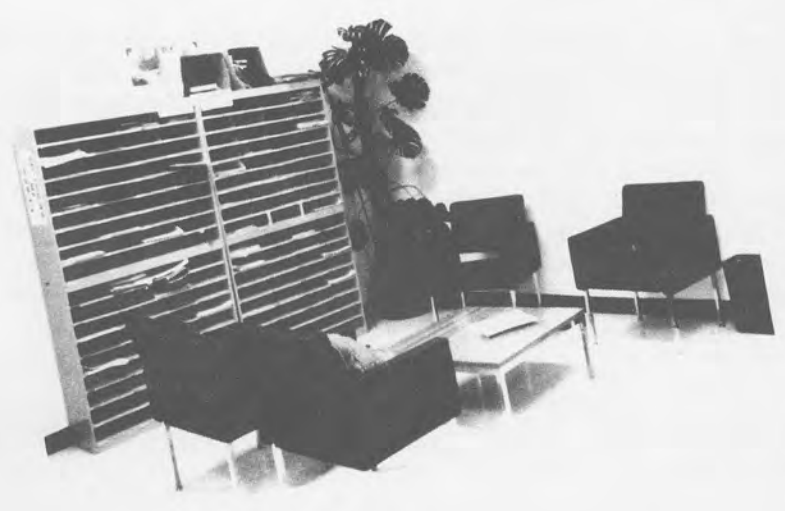

## DEPARTMENT ACTIVITIES

Progress is all around us literally. We are now in our new building as the photographs on the cover show. We have almost finished the programming for the Buell Building, which will bring Architecture, Landscape Architecture and Planning into the same building on South Campus. We have five new faculty in the past two years and we are about to hire two more. We are coping with significant increases in class sizes, reminiscent of the mid-seventies rather than the eighties. You have increased annual giving from under \$1,000 per year to over \$13,000. We have now graduated five students from the PhD program and at least four others are close to finishing. The core curriculum in the MUP program is still being refined. We now have a fairly polished land development and site planning course and the Planning, Problems and Cases workshop continues to be a central part of each MUP students Spring. We are increasing our effort in the BAUP program, focusing the curriculum committee on it this year and launching a new course aimed at sophomores in each of the last two years. We have received support from the campus to launch a long talked about urban neighborhood extension program focused on East St. Louis. Our research and contract efforts are continuing to yield financial support and work experiences for students and equipment and resources for the department that would not otherwise be available.

Our alumni activities are bringing good professional and personal results. On a recent visit to Phoenix, I had dinner with about eight alums. One was there from Chicago as a consultant to an agency in which another was the associate director. The agency staff contact was also one of our alums. She obtained that job after having served an internship there while a student based on an alum contact. Two of the others also worked at the same agency. Our alums are a professional network. Whether a recent grad or senior partner, whether looking for a job or looking for a job candidate, our network of alums is a first-rate source. We do maintain placement files, so contact our placement office at (217) 244-5419 if you are looking. The Illinois Planning Symposium held last fall was a great success professionally and in enriching friendships. I look forward to seeing you at APA in Denver, at the Illinois Planning Symposium next fall, or here on campus. If you are interested in organizing a Dutch treat alum get together in your area, let me know and I will let you know when my travel schedule sends me your way.

## TEMPLE HOYNE BUELL HALL

A gift of six million dollars from Temple Hoyne Buell, a graduate of the School of Architecture, has been matched by state funds. We have almost completed the programming and hope to move into the building in August, 1993.

On this campus, architecture, landscape architecture, and planning have developed strong, but largely independent and separate programs. Each has been successful, but we face constraints compared to our peer programs, which typically benefit from greater interaction and shared resources among the equivalent three units. The Buell gift is thus not just an opportunity to solve some problems of inadequate space, but an opportunity for new initiatives and accomplishments. The building will encourage greater interaction and thus build on the strength of the individual units. Proximity will allow sharing of facilities and ideas, greater awareness on the part of students of the approaches of related professionals. For planning students and faculty in particular, Temple Buell Hall will also bring us closer to the faculties of the College of Commerce, the College of Law, the Natural History Survey, and the University libraries with whom our



planning faculty already interact in interdisciplinary activities. The new physical facilities and the enriched community of students and faculty will aid in accomplishing our mission of planning for the social, environmental, economic and physical concerns of urban development.

**NOTE:**

Temple Hoyne Buell died in January 1990 at the age of 94. He received a degree in Architecture from the University of Illinois in 1916. Mr. Buell was a prominent Colorado developer and architect and was regarded as "the father of the modern shopping center."

## **CPLA LIBRARY**

1989 has turned out to be quite a year for staff changes! Mary Ravenhall, the CPLA Librarian, is taking a year long sabbatical with her husband in Denmark. She will be doing research for a bibliography while she is there. Assigned as Acting CPLA Librarian is Mary Beth Allen, who has coordinated the Undergraduate Library's bibliographic instruction program during the past three years. Among other staff changes, Anita Schuneman replaced Sue Umdenstock as our Graduate Assistant responsible for cataloging new books. Betty Heggemeier, our half-time Library Technical Assistant left in November and Douglas Kistler was hired to replace her.

Laura Montgomery left after 11 years with CPLA to follow her husband's career move to the University of Michigan in Ann Arbor.

*Some of the highlights of the past year include the purchase of a new revolving display rack which provides efficient access to many of our current periodicals and library handouts. Also, we were able to consolidate our card catalogs, allowing us to remove one entire cabinet and freeing space for a larger table and a second Online Catalog terminal.*

As for Library acquisitions, two new periodical titles include RESOURCE RECOVERY and CHILDREN'S ENVIRONMENT QUARTERLY. Approximately 975 new books were added to the Library's collection, and many welcome gifts were donated to the Library by retired Urban Planning faculty members, Albert Guttenberg and William Goodman.

## **CONTINUING EDUCATION**

The Department continues to offer its Institute on Planning and Zoning each year for a large turnout of local planning officials and planning and development consultants. The Spring 1989 Institute was held at Pheasant Run Resort in St. Charles, Illinois and drew participants from the Chicago-land area along with many downstate local planning officials. The Institute is largely self supporting, through joint sponsorship by the Illinois Chapter of the American Planning Association.

## INTERNATIONAL ACTIVITIES

In collaboration with the School of Architecture and the Department of Landscape Architecture, Department scheduled a summer program at Tongji University at Shanghai, China. The program was cancelled because of the political events in China this past June. We hope to conduct a program there in the summer of 1991.

Professor Gill-Chim Lim organized the International Seminar on negotiation for Senior Decision-Makers in Seoul, Korea in July 1988. He also co-chaired the International Conference on Development in Newly Industrialized Countries and Beyond, at the University of Maryland in June of 1989.

**IN MEMORIUM  
HARLAND BARTHOLOMEW**

Harland Bartholomew died in December 1989 at the age of 100 after a brief illness. Mr. Bartholomew taught a Civic Design course, "Planning of Towns and Cities," at the University of Illinois as a non-resident faculty member from 1919-1956. He was the first full-time municipally employed American City planner.

Mr. Bartholomew's firm, Harland Bartholomew and Associates, prepared comprehensive plans for more than 500 communities in the United States. He served as an engineer for the City Plan Commission of St. Louis for 34 years, until his retirement in 1950. During that time he was involved in projects resulting in the Gateway Arch, the centerpiece of the Jefferson National Expansion Memorial and the major street plan developed in 1932 for St. Louis.

Mr. Bartholomew was a former chairman of the National Planning Commission and had been a consultant to Presidents Herbert Hoover, Franklin D. Roosevelt, Harry S. Truman and Dwight D. Eisenhower.

## FACULTY AND STAFF

Now that we have a new structure, the administration, placement and advising offices are located at 907 1/2 W. Nevada. We continue to use the four houses -- 907, 909, 1001, and 1003 for faculty offices and research, student offices, classrooms, funded grants and contracts, and storage. With the addition of new faculty in the fall we will once again find ourselves using every available square foot of space. Therefore, we are looking forward to the next move, which is scheduled for 1993, into a new Architecture/Landscape Architecture/Urban Planning building which will be built with funds donated by an architecture alum, Temple Hoyne Buell.

## FACULTY

**Donaghy, Kieran** Having completed one full year in the Dept., I am now reasonably well settled and starting to make forward progress. I am teaching three courses concerning various planning methods and working with a handful of MUP and Ph.D. students on theses that are generally concerned with questions of economic development. I am highly pleased by the seriousness of purpose and level of scholarship the current class of MUP students has demonstrated. On the research front, I have been exploiting the University's marvelous supercomputing facilities to work with models of coordinated economic policymaking, including possible responses to global environmental problems. I have also been studying the question of how military production facilities can be converted to civilian uses while maintaining or increasing overall employment, and have been developing some software that will enable planners using the Dept.'s on-line economic impact forecasting system (EIFS) to evaluate tradeoffs between economic and environmental impacts of proposed development projects. In work with an extension service orientation, I am advising the City of Dayton, OH on a scheme to effect tax-base sharing and the Delaware Dept. of Transportation on a method for adjusting incentives to induce greater ridesharing in the City of Wilmington. My wife, Victoria Pifalo, has also adjusted well to her new position as a Health Sciences Librarian on campus and we look forward to productive years, respectively, in 1990/91.

**Forrest, Clyde** We are all looking forward to the Dept. being fully staffed for the first time in several yrs. Staff turnover gives me pause as I realize that I am now the senior faculty member of DURP. Who would'a thought that a country lawyer/planner from Oklahoma would find a permanent home at the "BIG U". Current work finds me doing things for APA and AICP, news letter, annual meeting program, professional development, university program accreditation site visit team, and the Wetmore fellowship. An interesting new project is wetlands preservation for IL Dept of Conservation. Some radical developers' lawyers are telling local governments that the 87 Trilogy prevents wetland regulation! I think not and am writing a paper to state the case for reasonable, planned regulations that will preserve wetlands. I hope this sounds familiar to all former students and that you can give the rulings in the trilogy. Hope to see you at the next national APA meeting or at DURP'S own annual Institute on Planning and Zoning, or both!

**Freund, Eric C.** (Emeritus) As mentioned in my last newsletter, I am still using the word "retire" as an antonym, and am as busy (if not busier) as I was when teaching, although engaged in somewhat different pursuits. Early in '89 I returned from Britain, where I had been carrying out some research projects for about 9 months (as well as "smelling the roses" now and again!), and joined a U.S. Army Corps of Engineers team as a consultant, our task being to produce 2 video tapes on the planning of an ideal Army base. I was involved in this until early Sept., when the endeavor was most pleasantly terminated by the arrival of Daphne, the very close friend of mine from England who I mentioned in my last newsletter. This time we did not attempt to travel the whole of the United States in a month, but contented ourselves with visiting the Statue of Liberty (which I last saw at close quarters when climbing the scaffolding when

with visiting the Statue of Liberty (which I last saw at close quarters when climbing the scaffolding when the statue was under repair); Baltimore Harbor, given a new image as "Harborplace", courtesy of the Rouse Company; and Washington, D.C. which celebrated our visit by presenting us with a parking ticket! However, Prof. and Mrs. Forrest made Daphne's visit to Urbana memorable by presenting us with a most enjoyable party to celebrate our closer union at a future date yet to be determined. We also met with Adrian (my son) who gallantly drove down to Westfield, N.J.--the furthest pt. East in our journey where we stayed with my cousin--from Hartford, CT, where Adrian was recently appointed Chief of the State Water Resources Division. However, this achievement was dwarfed by another of far greater significance, for on June 7, '89, he and his wife Karin (who did most of the work!) together produced the loveliest little grandson--Justin--for me to cherish. This balanced up the score somewhat, for Daphne's daughter presented her with a little treasure--Jamie--on Dec. 27, '88 so we can both be proud grandparents together! We returned to England on Oct. 6, since then I have been travelling and carrying out research on a number of topics for The Construction Specifier, the magazine of the Construction Specification Institute, which circulates to most architects, engineers, and associated professionals in the United States and selectively, elsewhere. The most challenging of these topics is concerned with the advent of the European Economic Community (EEC) in '92, and its impact on professionals associated with architecture, construction firms, and the manufacturers of building materials. The regulations which will govern all these aspects are still under consideration at all levels, and few people appear to have a comprehensive grasp of the present situation. This is in marked contrast to the several development and redevelopment projects which I also have to research, where plans and ground works may be seen and examined. These projects include the redevelopment of the London Docks and the Chatham Docks (formerly a British naval dockyard, now to be developed as an enterprise zone and marina), and the proposals for building a replica of Shakespeare's Globe Theater on its original site on the South Bank of the River Thames in London. These projects, together with the restoration of the Pantiles, Tunbridge Wells, Kent (beloved of Beau Brummel in the 1700's); the restoration of the village of Old Isleworth, on the River Thames, not far from the place where Queen Boadicea fought the Romans as they sought to ford the Thames; and others, form the subject matter for articles which I will write in the future. Those I have written in past yrs. include Renovating Commercial Structures; Restoration-on Both Sides of the Atlantic; Saving Sinking Cities-Flood Control in London and Venice; Saving the Monuments of the Athenian Acropolis; The Lure and Rationality of Water-related Development; Erddig-Rescue of a Grand Estate; Portrait of a Restorer as a Young Man; and others. The latest effort, published in Aug.'89, was on the English Channel Tunnel, probably the largest and most complicated engineering project ever carried out, which will, when completed, link England to France. This was a dream of Napoleon, who thought that thereby he could sneak up on the "Brits" and so win the Napoleonic Wars for France. Quite naturally this idea was not favored by said Brits at that time, and there are still many who don't think it a very good idea, and are comforted by the fact that some 21 miles of water separate the two cultures! So you can see that although theoretically "retired", I am still having fun and meeting some very interesting people during the course of varied and often fascinating research. I am still involved in ATAM 201, offered by the Graduate Program on Ancient Technologies and Archeological Materials, and pinch hit on one or two other courses in other depts. I return from England in April, and will be in the U.S. for a few months before returning here once again to carry out one or two professional projects. Those of you that know me, do write, care of the Dept. I promise that I'll reply, wherever I am!

**Goodman, William** (Emeritus) Although I am retired, I am still ripping off the Department but not as much as the people who are not retired.

**Guttenberg, Albert** (Emeritus) Life is what we expected it to be in this beautiful, vibrant city on the Potomac--hectic, invigorating and dangerous; but C-U also has its charms. In any case, we have to be back in June to attend to our house and other matters. See some of you then.



**Heumann, Leonard** Another full year has gone by. My research team has completed a major study of the 202 housing program--the nations oldest and largest program for the elderly and handicapped. Public service, especially as president of United Way of Champaign County is very demanding given all the government resource cutbacks. I have been ailing with 2 slipped disks in my back for almost a year but its almost back to par. Rob is still an OB-GYN nurse and deeply involved in "guiding "her children--the 2 older ones are beyond "raising". Surena is a practicing architect, Aaron is a Soph. in Civil Engin. here at IL and Micah is a nice, mellow and wise beyond his years, 9 yr. old.

**Hewings, Geoff** I will step down as Head of the Geography Department in May, 1990 after 7 1/2 yrs. in this position. Thereafter, I will devote half-time to the Regional Economics Applications Laboratory, a joint venture between the Federal Reserve Bank of Chicago and the University of Illinois. I serve as Director of REAL. In June/July, I will be returning to Indonesia to continue work on the development of a set of regional and interregional social accounts.

**Hogue, Barry** (Visiting) On the professional side, one of the more interesting projects I'm working on now is a contract our firm has with the Urban Land Institute (ULI). We are identifying, documenting, and evaluating examples of successful growth management in U.S. cities that have experienced rapid growth over the last decade. To date, we have selected 25 cities/counties for which we have written brief case studies. Out of this group, five cities have tentatively been chosen for in-depth analysis and reports. ULI staff has shared the work load with us on this assignment that is scheduled for completion and publication this Spring. Right now, I'm also working on a comprehensive plan for O'Fallon, IL; a couple of tax increment financing jobs in Illinois and St. Louis; growth management regulations in new Castel County, DE ; and an industrial park plan in Columbia, IL. In February, I will participate in planning "charrette" for the Lafayette Town neighborhood in St. Louis; we are subcontractors on the job to Andres Duany, the urban design guru who planned the Seaside project in Florida. On a personal note, our oldest daughter, Gina, entered dental school this Fall and my racquetball game still stinks.

**Lewis D. Hopkins** I have made good use of my residual skills and interests in architecture and landscape architecture in the last year. We worked hard on the new building and moved in last April. There have been plenty of details to worry about, from heating systems to black boards, room sizes to door locks. We are regaining some of that "downtown" feeling in our lobby with lots of activity centered around the mailboxes, coffee pot, copy machine, seating, and doors to the placement office, main office, computer lab, rest rooms, and presentation lab. While this was going on we were recruiting for two faculty slots and I was pretending (only partially successfully) to be on sabbatical. I have made enough progress toward a book that I might actually get it written someday. Now we have begun the programming for the new Buell Hall, which involves detailed consideration of requirements for all department space. Have no fear. The equipment we have bought will go into Buell Hall and our "new" building will become the Dance Department's space. All carefully planned and we even got practice working out a new building before we had to do the permanent one. This fall I have been helping teach the land development and site planning course, a new course for MUP students. I also worked with Rosanna Mattingly and Claire Powers on a workshop focusing on East St. Louis. We expect to continue to work in that area with additional support from the university. John Kim, Doug Johnston, and I organized a PhD seminar on planning decision support systems, which drew about ten students (half for credit) and provided a great forum for learning about what research each of us, faculty and students, is doing. **Kim, T. John** Hello to everyone! You may not believe that my son, Youngmoo, is in College this year. But it is true. On my research side, you may want to look at the book I edited and released recently by the Springer-Verlag Publishers in New York which is titled, Expert Systems: Applications to Urban Planning. I have several research projects funded by National Science Foundation, the Office of Strategic Initiative, and the Construction Engineering Research Laboratory. These projects are developing Expert Systems, Research on Planning and Development of Infrastructures in Kenya, Economic Development in Indonesia, Developing a Planning Model for Infrastructure Development for Korea, and Developing a Hypertext system for Army Installation Planning. On the administrative side, I am still Director, Office of Overseas University Collaboration and the University Liaison Officer to the Midwestern Universities Consortium for International Activities, Inc. (MUCIA). This year, I am organizing a Conference on Public-Private Collaboration on Economic Development in Bandung, Indonesia in July 9-13, '90. Interested in joining? Let me know.

**Knaap, Gerrit** Got a great job and moved to IL from WI. They say the weather is better here, but in Dec. the temperature dropped to 23 degrees below zero, and my car wouldn't start. Fortunately, it warmed up in January, but our showers were cold because the water-heater broke. Then the ice storm hit, we weren't without power long, but when the power came on the furnace wouldn't start. After the repair person fixed the furnace, I took the car back to the shop. It seems the \$180 I spent to repair the problem with the steering fluid was insufficient. After the freeze ended it started to rain, and water backed up in our shower and leaked through the walls. **Lim, Gill-Chin** I took a sabbatical leave during the fall semester of 1988. It began with my participation in "International Conference on Hosting Olympic Games" in Seoul, Korea. I gave a speech on "Economic Strategies for Olympic Games," and led a workshop. Then I organized "International Seminar on Negotiation for Senior Decision-Makers" in Seoul. It was jointly sponsored by In-Ha University, Harvard Law School's Program on Negotiation, and Consortium on Development Studies of which I am the chairman. I also took a trip to China to attend the "Conference on Asian Urbanization," at Nanjing University where I conducted a field research on Chinese housing and urban development in August 1988. Upon returning from China to Korea, I started my research on housing in developing countries at the Korea

Research Institute for Human Settlements. While at the Institute, I wrote several papers and joined a number of policy workshops and public hearings. Of course, I took some time off from research to watch Olympic Games, to travel around the beautiful countryside, and to publish a book of poetry. In January 1989, I returned to Urbana. During the Spring Semester, I taught UP 101 Planning of Cities and Regions. I had a wonderful group of teaching assistants and students. I continued working on a few research projects including "Housing in Socialist Countries." I also organized and chaired a "Seminar on Chinese Housing and Urbanization", and "The Third International Conference on Planning and Development in Rapidly Changing Societies." It is time for me to take a break, I am going to ski down the Rockies soon.

**Mattingly, Rosanna** I'm not at all sure where this past year has gone, which in itself is sort of scary. It's been interesting, challenging, frustrating, and full. 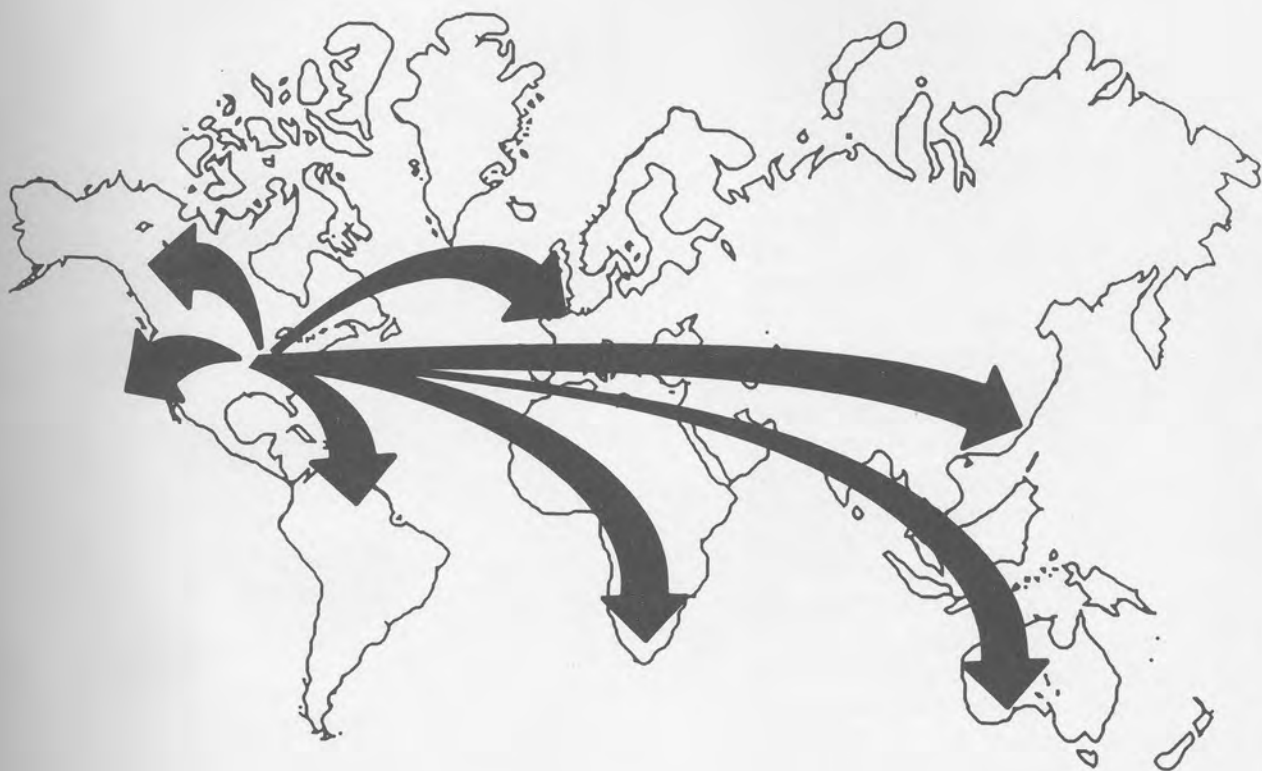
