
# **Course Information**

The Doctoral Urban Planning seminar is a platform for the intellectual development for PhD students in the <u>Department of Urban & Regional Planning</u> and part the program's strategy for building a thriving and successful community of scholars. The seminars facilitate exchange of ideas and perspectives among doctoral students, faculty, and others working to support academic research and practice.

The seminar is designed to support the progress and success of doctoral students who are at different stages in their research and doctoral studies, and provides a shared space for students to present their research and to solicit critical, yet constructive, peer reviews and advice.


### **Seminar Structure**

The Doctoral Urban Planning Seminar is designed to be a collaborative venture between seminar participants and the faculty facilitator. Faculty facilitation focuses on a 4-semester cycle of seminar workshops designed to build skills and perspectives that will support scholarly and research practice. The assumption is that doctoral students will cycle through all for seminar workshops during their pre-candidacy coursework:



These facilitated "workshop within a seminar" sessions are scheduled for roughly every other week. Seminar participants will work to set the agenda and approach to other sessions, which may include inviting faculty panels and guest speakers to reflect upon their work and experiences, inviting representatives from campus offices to share resources and tools, providing peer feedback on talks and presentations, etc. This shared agenda will be planned during sessions at the beginning and end of each semester.

## **Participation and Attendance**

Like any seminar, our shared success is predicated upon your full participation and engagement.

### **Participation**

The learning environment in this seminar depends upon your participation. Full participation is expected for all course sessions. Participation means not just being physically present, but also actively engaging in our discussions, evaluations, and providing feedback to each other.

#### **Attendance**

We will meet on a weekly basis, and you are expected to be present for all sessions. Attendance will be taken and full participation is expected to satisfy seminar requirements. In those cases where it is likely that many seminar participants are not available, we will cancel our session or modify our approach to that session. The overall seminar schedule attempts to account for major conferences and other events for which many students may be away from campus.
