Seminar Assessment

Your grade in the seminar will be based upon the following:

Attendance	20%	Attend class sessions as required by your chosen capstone pathway.
Participation	20%	Active participation, engagement, and contributions to our seminar.
Milestones	60%	Timely completion and engagement with seminar milestones. Production of work that exemplifies your identity as an urban planning professional.

Participation

The learning environment in this seminar depends upon your participation. Full participation is expected for all course sessions. Participation means not just being physically present, but also actively engaging in our discussions, evaluations, and providing feedback to each other.

Attendance

Attendance in our Capstone Seminar varies depending upon the capstone pathway you are pursuing:

- Workshop Pathway: Participate in designated seminar sessions, which will occur approximately once per month. Register for 0 credit hours of UP 591 in the fall and spring semesters.
- **Project Pathway:** Participate weekly in all seminar sessions. Register for 4 credit hours of UP 591 in the fall semester and 0 credit hours of UP 591 in the spring semester.
- Thesis Pathway: Participate weekly in all seminar sessions. Register for 4 credit hours of UP 591 in the fall semester and 0 credit hours of UP 591 in the spring semester.

Attendance will be taken and full participation is expected to satisfy seminar requirements.
