# **Section V-Emergency and First Aid Procedures**

EYE CONTACT: Immediately flush eyes with water for at least 15 minutes. Seek medical attention if any symptoms persist.

SKIN CONTACT: Remove contaminated clothing and shoes. Wipe excess from skin and flush with water using soap if available. Seek medical attention if irritation occurs. Do not reuse clothing until thoroughly decontaminated.

#### **Section IX-Environmental Protection**

SPILL OR LEAK PROCEDURES:

LARGE SPILLS: Evacuate the hazard area of unprotected personnel. Wear appropriate respirator and protective clothing. Shut off source of leak only if safe to do so. Dike and contain. If vapor cloud forms, water fog may be used to suppress; contain run-off. Remove with vacuum trucks or pump to storage/salvage vessels. Soak up reside with an absorbent such as clay, sand or other suitable material; place in non-leaking containers for proper disposal. Flush area with water to remove trace residue; Flush solutions as above.

SMALL SPILLS: Take up with an absorbent material and place in non-leaking containers; seal tightly for proper disposal.
